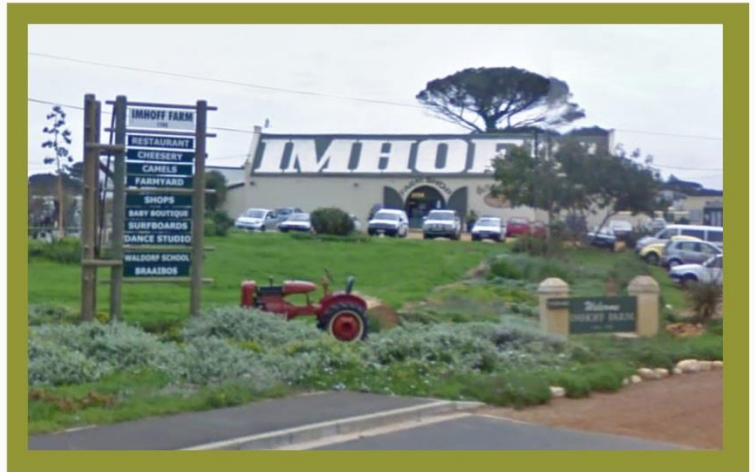

## IMHOFF FARM, KOMMETJIE - DIRECTIONS

Head towards Muizenberg along the M3 and turn right at the T-Junction at the end of the highway. Turn left into Ou Kaapse Weg (M64). Once you are over the mountain, you will approach a set of traffic lights. Go straight at the bottom of Ou Kaapse Weg. Longbeach Mall will be on your right. At the 2nd set of traffic lights there is a big 4-way intersection. Turn right (towards Kommetjie) and drive towards the next set of robots, opposite Ocean View, then turn right. On your right you will see Imhoff Farm. Drive past the parking in front of the Farm Stall. The road bends to the right, past the cheese factory. Drive through the farm gate where you will see the goats on the left hand side, and parking along the back wall of the stables on the right. Park here and walk towards the little green security hut, through the farm gate. Take the left hand fork in the road which will lead you to the Paintball/Lasertag rest area and field.
